ASSUMPTION OF RISK, RELEASE OF ALL CLAIMS AND INDEMNITY AGREEMENT

I understand that there are inherent and other risks involved in the use of firearms up to and including, bullet ricochets and/or "splash backs". Splash backs are bullets that hit steel or other hard surfaces and fragment. The fragments fly back toward the firing line and may cause bodily harm if it strikes a shooter or observer. A range shooter can shoot themselves or others or be shot by another range shooter by accident. I freely assume those risks, including the risk of serious injury or death.

I also understand that shooting firearms will cause **LEAD and NOISE** exposure as both are emitted from shooting. Bullets and primers are made of lead, cleaning firearms or even handling firearms causes lead exposure. The sound percussions are also created by firearms and can cause irreversible hearing damage. Proper hearing protection is mandatory while on the range. Improper firearms handling can lead to burns, cuts, or minor and/or serious injuries.

I agree to **RELEASE, HOLD HARMLESS AND INDEMNIFY** the Bellevue Indoor Range / Wade's Eastside Guns, the manufacturers and distributors of firearms, ammunition and accessories, and their owners, agents and employees from any and all liability for damage and injury to myself or any person or property resulting from any cause, including but not limited to negligence, improper selection, adjustment and use of firearms and ammunition.

I will accept for use, as is, any equipment rented or provided to me and accept full responsibility for its use. I will be financially responsible for replacement at full retail value, any equipment rented or provided under this agreement that is not returned to the Bellevue Indoor Range and will reimburse the Bellevue Indoor Range for any loss or damage, other than reasonable wear and tear. I will return all equipment rented or provided prior to departing the building.

I agree that it is my responsibility to know how to properly and safely use any equipment rented or provided to me. I will ask for any instruction or direction necessary prior to use. I understand the function of the equipment and will not misuse or abuse the equipment. If I rent a firearm from the Bellevue Indoor range I agree I must use their ammunition.

I am not legally restricted from possessing firearms.

I will not provide services such as firearms training in exchange for money to any person or persons on the premises of the Bellevue Indoor Range.

I am legally competent to sign this release or my parent or guardian has also read and signed this release. If I am less than 21 years of age, signature of a parent or legal guardian over 21 is required. Exceptions would be shooters 18 years old and renting or shooting rifles only.

I will immediately obey any safety directives or warnings given to me by any member of the Bellevue Indoor Range staff. I further agree that if I fail to immediately obey any directive I will remove myself and my belongings from the premises unless asked to remain pending the arrival of law enforcement personnel.

I recognize that Bellevue Indoor Range, INC. would never rent me any firearm(s) if it had any reason to suspect that these oaths or affirmations are untruthful in anyway, and if I violate any of these oaths or affirmations, I accept full and sole responsibilities for my actions, and I agree to allow Bellevue Indoor Range, INC. to use this document in any form whatsoever to demonstrate my deceit, dishonesty and misrepresentations.

I have read this agreement in its entirety and fully understand its contents. I am aware that this release of liability is a binding contract and I sign of my own free will. I also agree to present legal and valid identification.

BELLEVUE INDOOR RANGE, INC. WADE'S EASTSIDE GUNS CUSTOMER SAFETY & RENTAL AGREEMENT

Everyone who wishes to shoot in this facility, whether shooting their own firearm or a rental firearm **MUST** completely fill out this form **INITIAL AND SIGN** and have a valid passport, US ID or, Canada ID that will be checked by Range staff. This waiver is good for (1) year.

Bellevue Indoor Range Safety Rules:

Initial

1. I swear and/or affirm that I am of good character and moral standing and am legally entitled to possess and/or purchase a firearm. I have no criminal convictions, pending criminal charges, indictments nor suffering from any form of mental illness that would prohibit me from legally and safely possessing and using a firearm. _____
2. You must be completely in a shooting booth before uncasing or un-holstering a gun and the gun must be unloaded and put back in a case or holster before coming out of the booth.
DO NOT WALK AROUND THE RANGE WITH FIREARM IN HAND. _____
3. Keep your finger off the trigger until your sights are on the target. Keep your finger off the trigger while loading, unloading or looking at the target to see if you've hit it. _____
4. Put the gun on the table to look or speak to someone behind you. If you are holding a gun you need to pay attention to the gun. If your head turns, your body and the gun will follow. Keep the muzzle pointed down range at all times and do not put any part of your body forward of the firing line, which is the front of the booth, for any reason. _____
5. Shooters will only fire at paper targets hung from the carrier in their assigned lane. Cross-lane firing, or shooting at anything other than your own target is strictly prohibited. Any person seen firing at lights, baffles, carriers, walls, clips or any other range property or equipment will be removed from the range, barred from future use of Bellevue Indoor Range facilities, and reported to the proper authorities for appropriate action. You will be held accountable and will have to pay for any damage you cause by not following these range rules. Report all incidents to the range counter immediately. _____
6. Any shooter under 18 years old must have an adult one arms distance from them at all times. _____
7. No practice drawing from the holster. **Unless you are a member or law enforcement and have completed the safety check by range staff.** _____
8. Ammunition fired on the range must be brass cased and jacketed or partially jacketed. Steel or aluminum cased ammunition, i.e., Wolf or CCI Blazer, as well as lead wad cutters or semi-wad cutters are specifically prohibited. There are a few rare exceptions but you **must** ask the Rangemaster for clarification. _____
9. **YOU MUST SHOOT OUR AMMUNITION THROUGH OUR RENTAL GUNS.** Unused ammo may be taken with you from the range, but will not be accepted for use in rental firearms on future visits. All ammo to be fired through range rentals must be purchased and used that day. _____
10. You are welcome to keep brass that went through your gun and you may pick it up as long as it is not forward of the firing line. **Do not reach forward of the firing line ever.** We will not call a cease fire to retrieve brass beyond that distance. Leave all other brass on the range. _____
11. Security Guard training and/or qualification are not permitted on this range without a contract. _____
12. Eye and ear protection **must** be worn upon entry to, departure from, and at all times in the range. _____
13. **NO** food, beverages or tobacco use allowed in the range. _____
14. Alcoholic beverages and/legal or illegal drugs are prohibited on Bellevue Indoor Range property and are not to be used prior to arrival to the range. We have the right to refuse services to anyone that has the smell of alcohol or drugs on their breath or clothes, or who appears to be impaired. _____

Universal Firearms Safety Rules:

1. All firearms are always assumed to be loaded. _____
2. Always keep the muzzle pointed in a safe direction. **(down range at all times)** _____
3. Keep your finger off the trigger until you are ready to fire and your sights are on the target. _____
4. Always be sure of your target and what is behind and beyond it _____
